**NOTICE OF PUBLIC MEETING**

Notice is hereby given to all interested members of the public that the Board of Directors of the above-captioned District will hold a public meeting at **13850 Cutten Road, Houston, Harris County, Texas 77069**, said address being a meeting place of the District.

The meeting will be held on **Monday, November 3, 2025, at 6:00 p.m.**

The Board shall consider and discuss the following matters and take any action appropriate with respect to such matters:

1. Review and consider approval of the minutes of the October 6, 2025, and October 7, 2025, Board of Directors meetings;
2. Consider the status of security patrol from the Harris County Sheriff's Office, the status of security monitoring services, and the taking of any actions required in connection therewith;
3. Consider comments from members of the public;
4. Consider review and approval of Interlocal Agreement relative to participation in Harris County Public Health's Wastewater-Based Epidemiology Program;
5. Status of solid waste collection services by Texas Pride Disposal, including review of annual CPI adjustment, and the taking of any actions required in connection therewith;
6. Tax Assessor-Collector report, including status of delinquent tax accounts, and the taking of any action in connection therewith, including authorizing the payment of invoices presented, approving tax refunds and approving the moving of accounts to uncollectible roll;
7. Operator's Report, including:
  - a) Appeals of District charges;
  - b) Refer accounts for collection and approving write-off of uncollectible accounts; and
  - c) Report regarding status of maintenance projects, and the taking of any actions in connection therewith;
  - d) Consider status of FEMA reimbursement;
8. Engineer's Report, including:
  - a) Report concerning bids and/or award of construction contract or concurrence in the award of a contract for the construction or repair of water, sanitary sewer, drainage and recreational facilities within the District; status of construction contracts, including the approval/concurrence of any change orders and/or acceptance of facilities for operation and maintenance purposes, and acceptance of site and/or easement conveyances for facilities constructed or to be constructed for the District;
  - b) Status of the North Harris County Regional Water Authority ("Authority");
  - c) Report on operation of flare from TYEG;
  - d) Report regarding maintenance of park property and trails and consider authorizing repairs relative to same;
  - e) Consider status of preparation of Geographic Information System for the District;

10. Consider annual review of Order Establishing Policy for Investment of District Funds and Appointing Investment Officer, and adoption of Resolution in connection therewith;
11. Consider approval of changes to bylaws of the Association of Water Board Directors and designate voting representative in connection with same;
12. Matters for possible placement on future agenda.
