**NOTICE OF PUBLIC MEETING**

Notice is hereby given to all interested members of the public that the Board of Directors of the above-captioned District will hold a public meeting at 13850 Cutten Road, Houston, Harris County, Texas 77069, said address being a meeting place of the District.

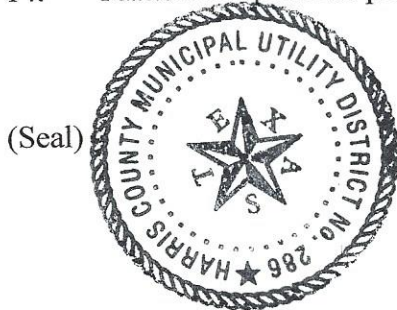
The meeting will be held on Monday, June 3, 2024, at 6:00 p.m.

The Board shall consider and discuss the following matters and take any action appropriate with respect to such matters:

1. Review and consider approval of the minutes of the May 6, 2024, Board of Directors meeting;
2. Consider the status of security patrol from the Harris County Sheriff's Office, the status of security monitoring services, and the taking of any actions required in connection therewith;
3. Consider comments from members of the public;
4. Acceptance of Qualification Statements and Oaths of Office for re-elected directors;
5. Election of officers of Board of Directors;
6. Tax Assessor-Collector report, including status of delinquent tax accounts, and the taking of any action in connection therewith, including authorizing the payment of invoices presented, approving tax refunds and approving the moving of accounts to uncollectible roll;
7. Authorizing the Delinquent Tax Collections Attorney to pursue the collection of delinquent taxes for 2023 and prior years, including the filing of lawsuits regarding same, as necessary;
8. Operator's Report, including:
  - a) Appeals of District charges;
  - b) Refer accounts for collection and approving write-off of uncollectible accounts; and
  - c) Report regarding status of maintenance projects, and the taking of any actions in connection therewith;
  - d) Consider status of cleaning basin and clarifier at WWTP;
  - e) Consider status of FEMA reimbursement;
  - f) Status of payment by Mexcor for costs resulting from the unauthorized introduction of industrial waste into sanitary sewer system by Mexcor;
9. Engineer's Report, including:
  - a) Report concerning bids and/or award of construction contract or concurrence in the award of a contract for the construction or repair of water, sanitary sewer, drainage and recreational facilities within the District; status of construction contracts, including the approval/concurrence of any change orders and/or acceptance of facilities for operation and maintenance purposes, and acceptance of site and/or easement conveyances for facilities constructed or to be constructed for the District;

  - e) Consider status of Phase 2 cleaning and televising of sanitary sewer lines in the District;
  - f) Consider status of preparation of Geographic Information System for the District;
  - g) Consider review and approval of site plans and authorization to advertise and/or solicit bids for the installation of pickleball court;
  - h) Status of plans, usage submittals and inspections from Mexcor;
10. Consider adoption of Industrial Waste Order;
11. Bookkeeper’s report, including review of financial and investments reports, and taking of any action required in connection therewith, including authorizing the payment of invoices presented;
12. Authorizing completion, execution and filing with the Secretary of State of Voting System Annual Filing Form relative to District elections;
